Meeting Minutes

Call to order: 10:01AM

Agenda Review and Round Robin Introductions

Chair Report (Jim DaMico)

Revisions to the bylaws were passed at the May 11th Membership meeting. Community liaisons were added to strengthen community networks. The first partner under that umbrella is OH Dig and we hope to add other orgs to the mix to broaden OPC's reach.

OPC is working with the State Library to revise the LSTA grant process and make it more accessible.

Jim and Jamye will be presenting at the Ohio Local History Alliance. Jim will give an overview of OPC, the benefits of membership, and available grants. Jamye will present the treatment, digitization, and rehousing of a historic document.

We will be looking for two positions in Nov – Assistant Chair, Secretary

Chair Elect Report (Ginnie Dressler)

Working with OH Dig to finalize the MOU for partnership. Completed some updates to Wild Apricot.

Approval of Minutes (Jamye Jamison)

Minutes for the March 2023 Membership meeting were distributed to members over email. Jamye asked if there were any changes. None noted.

Eric proposed to accept the May Meeting minutes as written. Miriam second. All in favor. Jim brought paper copies of minutes from the past 3 years to the State Library for the OPC archives which are housed here.

The issue was raised about what should be done with born digital records – leadership will discuss this further and present possible options to the State Library and membership.

Finance Report (Miriam Nelson)

Not a lot of activity in the OPC account. \$17149.96 is the current balance. There were a few expenditures for new swag, but we need to spend down more in the account. Apply for grants! We could start doing more in person workshops as well.

Membership Report (Kristen Muenz)

The results of the survey indicated that people were interested in hybrid meetings so this is our first one. Another suggestion was to have round robins on specific topics at meetings so more people can participate and problem solve together.

Education Report (Amber Bales & Eric Harrelson)

Education plans for rest of year are set. As per the previously mentioned survey results, November will be a round robin with 6-7 small presentations. They will be sending out a google form to recruit participants. The next meeting will be virtual.

Outreach Report (Andrew Mancuso & Gena Reynolds)

The new OPC bookmarks have been designed – Jim will have 150 printed. The website has been updated with member map. The Walter listserv has been acting strangely – many people have been getting the emails but some have not. Next Updating resources/vendor list on website.

LSTA Update (Evan Struble from The State Library of Ohio)

The revised LSTA 5 Year plan starts Oct 1st with a first draft due by 17th and final draft due on 31st
